

ORDINANCE NO. 15.

AN ORDINANCE OF THE VILLAGE OF CASTLEFORD, TWIN FALLS COUNTY, IDAHO, APPROPRIATING THE SEVERAL SUMS OF MONEY DEEMED NECESSARY TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES OF SAID VILLAGE; DESIGNATING THE DIFFERENT FUNDS TO WHICH ALL REVENUES SHALL ACCRUE AND FROM WHICH SUCH APPROPRIATIONS SHALL BE MADE, EXPENDITURES AUTHORIZED AND WARRANTS DRAWN ON THE VILLAGETREASURER FOR THE FISCAL YEAR BEGINNING ON THE FIRST DAY OF MAY, 1945 , AND ENDING ON THE LAST DAY OF APRIL, 1946, AND PROVIDING THE TIME WHEN THIS ORDINANCE SHALL TAKE EFFECT,.

BE IT ORDAINED BY THE CHAIRMAN AND THE BOARD OF TRUSTEES OF THE VILLAGE OF CASTLEFORD, IDAHO:

Section 1. The General Fund is hereby designated as the proper fund into which all revenue accruing to said village from fines, licenses and by taxation for the purpose of paying the general expense of operation of said village during the taxable year beginning on the first day of May, 1945. and ending on the 1 last day of April, 1946, shall be paid for the payment of the ge general operating expenses of said village.

Section 2. There is hereby created a fund hereby designated as the Special SIDEWALK and CROSSINGS Fund and as the proper fund into which all revenues accruing to said village by taxation or otherwise for sidewalk and crossing purposes during said fiscal year shall be kept, and from which shall be paid the costs of sidewalks and crossings of said village.

Section 3. There is hereby created a fund hereby designated as the Special Street LIGHTING Fund and as the proper fund into which all revenues accruing to said village by taxation or otherwise for street lighting purposes during said fiscal year shall be kept, and from which shall be paid the costs of lighting the streets of said village.

Section 4. There is hereby created a fund hereby designated as the General Street IMPROVEMENT Fund and as the proper fund into which all revenues accruing to said village by taxation or otherwise for general street improvements during said fiscal year shall be kept and from which shall be paid the costs of general street improvements of said village.

Section 5. The following sums of money, or so much thereof as may be necessary, are hereby appropriated from the several funds for the purposes for which the money accruing to said funds shall be collected as follows:

Section 6. This ordinance shall take effect and be in full force from and after its passage, approval and posting, and shall be known as the Annual Appropriation Bill for the fiscal year 1945- 1946.
